STATE ITEM OF BUSINESS: Set County Truth in Taxation dates for 2025 Budget

BACKGROUND: Olmsted County must comply with the Minnesota Department of Revenue Truth in Taxation requirements which require each county to certify its proposed property tax levy for payable 2025 to the County Auditor (Olmsted County's Director of Property, Records and Licensing) on or before September 30, 2024.

The County's final property tax levy adopted in December cannot exceed the proposed property tax set in September 2024. The Board of the Olmsted County HRA will certify its own separate 2025 tax levy at its meeting set for September 10, 2024 and the County Board will acknowledge the certification of the HRA's 2025 levy at its meeting on December 17, 2024.

ACTION REQUESTED:

Set the dates, times and places for the meetings regarding the 2025 Budget and approve the supporting resolution as follows.

A. 2024 Resolution - Set Truth and Taxation Dates for 2025 Budget

Resolution No. 24 -

WHEREAS, the Minnesota Department of Revenue Truth in Taxation instructions require each county to certify its proposed property tax levy for payable 2025 to the County Auditor (Olmsted County's Director of Property, Records and Licensing) on or before September 30, 2024; and

WHEREAS, pursuant to Minnesota Statutes Section 275.065, subd. 3, counties are required to hold a single meeting in which the public is allowed to speak and the budget and levy is discussed. This meeting may be part of a regularly scheduled meeting but must be held after November 24, 2024 and must be held at 6:00 PM or later; and

WHEREAS, counties are to adopt their final payable 2025 property tax levies and their payable 2025 budgets prior to certification of their 2025 tax levies; and

WHEREAS, pursuant to Minnesota Statutes Section 275.07, counties must certify their final adopted payable 2025 property tax levies to the County Auditor no later than five working days after December 20 of each year; and,

NOW, THEREFORE, BE IT RESOLVED, that the Olmsted County Board of Commissioners hereby sets the following dates to take place in the Government Center Boardroom 151 4th St. SW in Rochester, MN:

September 17, 6:00 PM	Certify Olmsted County Proposed 2025 Levy
December 5, 6:00 PM	Truth in Taxation Public Meeting (Thursday)
December 17, 6:00 PM	Adopt the Final 2025 Budget and Levy
December 17, 6:00 PM	Acknowledge HRA Board's Certification of Its 2025 Levy
